Job Summary:

The Wintegration After-School Program engages children in after-school activities three days per week (currently Monday, Tuesday and Friday) at the program location in central Etobicoke. Programming incorporates moderate to vigorous physical activity (a minimum of 60 minutes every day) and a daily healthy snack. In addition, the program includes education on food and nutrition, wellness and personal health, and support for academic achievement. The Youth Program Worker is responsible for planning, implementing and reporting on the program.

Maintaining positive relationships with local partners and multicultural participants is key to project success. All agency employees are expected to support each other and to collaborate on agency-wide events.

Duties:

- Outreach and organize registration of children;
- Plan and prepare activities and promotional material, and publicize events;
- Development, oversight and implementation of a range of after-school activities focused on physical activity, nutrition and homework-help;
- Coordinate volunteers and students placements;
- Complete monthly reports and maintain program statistics.

Required Work Capacities:

- Training and experience in integrating physical activity in children's programs, and adapting physical activity
 opportunities to include children and youth at all levels of athletic availability and those with physical, sensory
